- * The parent/guardian will be notified by email (or postal mail if an email is not provided) of acceptance and the effective start date or rejection.
- * If the request is rejected, the notification will include the reason for the denial and steps to appeal the decision.
- * If a district does not respond to a request within 45 days of the request, the request is treated as a denial and the parent/guardian can appeal.
- * Under the Choice law, the nonresident school district becomes responsible for all matters related to the education of the student (basic education, special education, home/hospital services, truancy, CEDARS reporting, administration of state educational assessments, etc.). Legal Reference: RCW 28A.225.220 through 230.

This release will remain in effect while my student is enrolled unless I revoke such consent in writing.

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232(g); 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U. S. Department of Education.

FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level. Students to whom the rights have transferred are "eligible students." Parents or eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents or eligible students to review the records. Schools may charge a fee for copies. Generally, schools must have written permission from the parent or eligible student in order to release any information from a student's education record.

This Request to attend nonresident school district shall be dependent upon criteria for acceptance of nonresident district students established by the nonresident school district. In addition, the nonresident district reserves the right to revoke this transfer at any time throughout the school year if;

- Student does not follow the rules and regulations applicable to all students attending in the nonresident district,**
- It becomes necessary to change the education program/setting/placement of the student, and there is not room in the program to which the student would need to change,**
- Information provided by the applicant has been misrepresented,**
- Parent's full-time certificated or classified employment with the district ends, or**
- Nonresident student's placement displaces a resident student or if space in the grade level classes or programs becomes unavailable. When any of the above reasons occur, the transfer approval becomes null and void. Any further consideration for readmission must be based on completion of a new application.**
