## Preschool Registration

### Is Now Open!

Washougal School District's Community Education Preschools are located at the following Washougal School District Elementary Schools: Cape Horn-Skye, Columbia River Gorge, and Gause.

Our preschool curriculum supports "whole child" instruction with purposeful play, structured activities and hands-on teaching of social/emotional skills, literacy, math, science, physical education, and creative arts. Our teachers provide a depth of experience and commitment to kindergarten readiness in a safe and nurturing environment that recognizes each student's unique abilities. Our intent is to create an environment which fosters curiosity and creates a love of learning for preschoolers. Children attending our programs must be fully toilet-trained and must behave in such a way that they do not pose harm to self or others.

**Morning Preschool** classes serve 3-year-olds and young 4-year-olds. Curriculum is primarily play-based, with an emphasis on social/emotional skills and an introduction to learning and functioning within the classroom setting. Classes are 2.5 hours on Tuesday, Thursday and Friday. Class times vary based on the school location. Busing is available *to school* within the school boundary.

**Afternoon "Pre-K" Preschool** classes serve 4-year-olds and 5-year-olds that will be attending kindergarten the following school year. The Pre-K Curriculum is aligned with our district's K-5 curriculum and is more structured than our morning class, but also includes plenty of time for play and socialization. Classes are 3 hours on Monday, Tuesday, Thursday and Friday. Class times vary based on the school location. Busing is available *after school* within the school boundary.

**Enrollment is limited, so early registration is encouraged!**
