E. Comments-Citizens

Chelsea McClement spoke as parent and teacher on contract negotiations. We are losing some of the best teachers to neighboring districts.

Anna-Melissa Lyons, WEA President from Hockinson, spoke on contract negotiations, and expressed support for the teachers.

Rebecca Woodings teaches, lives, and grew up in Washougal, and spoke on contract negotiations.

Dawn Jayne spoke as a concerned parent on contract negotiations. She is surprised how badly the district is run, and how much money there is in reserve.

Scott Rainey, 8th grade US History at JMS, spoke on contract negotiations. We are losing good teachers, and it pains him to see collegues leave.

Sydney Termini, teacher in the district, spoke on contract negotiations and the price of health coverage. She had to take her husband off her insurance so she can afford it for her and her son.

Allison McGranahan, teacher, spoke on contract negotiations. The new building is stunning, and it is a privilege to work with the JMS staff. She would like to ask the board to ask the district to think about priorities.

Tim Pfeifer, teacher at CCMS for 28 years, spoke on contract negotiations. It's time to do the right thing and use the reserves.

Doug Cox, speaking as a citizen and as a teacher here for 36 years, spoke on contract negotiations. He is expressing his disappointment in compensation. How can we keep such a large reserve? It's time to use it. We have wonderful people working here, they all need to feel valued and welcome.

Jennifer Bohn-Snapp, band/choir/drama teacher at JMS, spoke on contract negotiations. With every passing year, she is finding it more difficult to make ends meet. She is tired of struggling, tired of feeling second class, and tired of disrespect.

Kathryn Baxter, teacher, spoke on contract negotiations and compensation. She asks the district to compensate fairly, teachers shouldn't have to struggle with daily needs.

Sue Conway, retired teacher, spoke on contract negotiations. She taught in Washougal for over 20 years. Worked tirelessly on bond, levy, and other committees. Teachers need the board to stand up and show respect.

Rhonda Reeser, CCMS teacher, spoke on contract negotiations. She is here to give her opinion on why the ratification did not pass. It's all about morale and the high turnover rate. Improving retention is the key, one way to do that is with improved compensation and education.

Mary Murray, teacher and Camas resident, spoke on contract negotiations. We will never retain the best and the brightest until we change something.

Nicole Yung, Washougal resident and teacher, spoke on contract negotiations. She is very excited to teach at the beautiful CRGES, but her heart is broken and she is embarrassed by how much she's making. Has loved all of her students, her children were born here.

Mike Conway, Washougal resident, spoke on contract negotiations. The board has options on how we spend the budget dollars. Supporting teachers is the best way to spend those dollars.

Lori Webb, teacher and Washougal resident, spoke on contract negotiations. She, parents, grandparents, and children all went to Washougal. She hopes her grandchildren will go here, too, but it's hard to defend if there are no good teachers. The community supported the board to be able to build the new schools. Pay teachers what they deserve.

Heidi Kleser, teacher, spoke on the lack of policies, or the lack of following policies across the district. Her building administrator said no appliances in classrooms, when it is allowed elsewhere and in the past. If there is a safety concern, we need to approach the situation more respectfully, so teachers don't feel singled out. There is not enough room in the staff room at JMS/CRGES for everyone or their lunches. We need strength in policy to help support us all.
