Board of Directors' Meeting Minutes Tuesday, November 3, 2015 Work Session 5:30 p.m.; Regular Meeting 6:30 p.m. Executive Session to follow Regular Meeting Washougal School District Office

1. WORK SESSION—DESIGN REVIEW: TRANSPORTATION, SECURITY & HVAC SYSTEMS

Board President Ron Dinius called the work session to order at 5:33 p.m. Doug Pruitt of BBL Architects presented schematic design drawings of the safety and security improvements (Gause Elementary, Hathaway Elementary, Cape Horn-Skye Elementary, Canyon Creek Middle School and Washougal High School), roofing and HVAC improvements, and the new transportation facility. Presentation boards were shared and handouts were distributed. At 6:20 p.m., Ron Dinius called for a brief recess ahead of the regular board meeting.

2. CALL TO ORDER, REGULAR MEETING—PLEDGE OF ALLEGIANCE

Ron Dinius called the regular meeting to order at 6:33 p.m. and Elaine Pfeifer led the pledge of allegiance.

4. COMMENTS—BOARD OF DIRECTORS AND ADMINISTRATORS

Legislative Representative Karen Rubino gave an update on what is going on in the legislature. The two big issues are the shortage of teachers and lack of capacity due to class size.

Ron Dinius shared the board will be attending the WSSDA Annual Conference November 20-22 in Bellevue.

5. STUDENT BOARD REPRESENTATIVE REPORT

The student representatives were tasked with answering the following question: "Based on your experiences, what do you believe are the essential skills and attributes of an outstanding teacher?"

Washougal High School Representative Dakota Payne answered with the following points: consistency, adjustability, relatability, tech savvy, and teaching for the students.

Excelsior High School Representative Krysia Woods answered with: caring, high expectations, making time for each student, patience, using different techniques, and being excited.

6. SUPERINTENDENT'S UPDATE

Superintendent Mike Stromme gave an overview of some things happening in the district. Hathaway Elementary had its first Family Resource Fair, with 65 families and 21 partners participating. Jemtegaard Middle School will be starting its "ManU" program, teaching 8th grade boys to be role models and leaders by teaching them many life skills. A similar program for girls called "Empowher" is in the works. The Salmon in the Classroom program is in full swing at Cape Horn-Skye Elementary.

Ron Dinius shared information about the process for citizen comments.

WAE President Frank Zahn shared that he had no new statements, but noted the 60 teachers in the room. They are going on two months with no contract, and he asked for the board's assistance in settling the negotiations.
