#### WASHOUGAL SCHOOL DISTRICT NO. 112-06

Board of Directors' Meeting Minutes Tuesday, December 8, 2015, 6:30 p.m. Washougal School District Office

**PRESENT**: Ron Dinius, Board Director; Teresa Lees, Board Director; Elaine Pfeifer, Board Director; Karen Rubino, Board Director; Bruce Westfall, Board Director; and Mike Stromme, Superintendent and Secretary to the Board.

## 1. CALL TO ORDER, PLEDGE OF ALLEGIANCE

Ron Dinius called the meeting to order at 6:32 p.m. and Teresa Lees led the pledge of allegiance.

## 2. AGENDA REVISIONS (none)

Ron Dinius noted the addition to the personnel report since the original mailing of board packets.

### 3. SUPERINTENDENT'S UPDATE

Mike Stromme shared that the district recently received notice that Cape Horn-Skye Elementary School (Cape) has been named a "School of Distinction" for the fourth year in a row, based on the school's reading and math assessment scores – an accomplishment to be proud of. The Stuff the Bus campaign collected more than 50,000 pounds of food this year. It has been exciting to see students leading in this type of community service. The Festival of Trees had more trees and more attendees than in previous years. Kudos to the organizers for this great event. The Washougal High School (WHS) choir had a superb performance at the Grotto recently. Lastly, Mike recognized Board Director Ron Dinius, who was honored at the recent Washington State School Directors' Association (WSSDA) conference for 10 years of service on the board. Mike added that Ron has also recently completed a Leadership WSSDA training course. He thanked Ron for his commitment to the district.

## 4. COMMENTS—CITIZENS

Andrew Schlauch, a fifth year teacher in the district, spoke about additional responsibilities that he has taken on to be able to support his family. He outlined teachers' options for employment more lucrative than current district wages, and thanked board members for their time.

Allison McGranahan, first grade teacher, stated that she loves what she is doing, but her position is not without challenges. She spoke about the extra time teachers put in and how they pull together to make sure that all students have good opportunities. She asked the board to support teachers as much as teachers support students.

Alice Yang, fourth grade teacher at Cape, has not attended school board or union meetings until this year. In her previous district in Texas, teachers had updated compensation, few out of pocket expenses and new equipment. Surrounding districts are offering higher compensation. On behalf of overworked and underpaid teachers, she urged the board to consider change.

Pam Ausman has taught at WHS for 15 years, and is serving on the negotiations team this year. She spoke about the district's reserve funds, and asked the board how much money in the bank is really needed.

Mallory LeCount is a fifth grade teacher at Cape. She teaches for her students, "her kids", knowing that she could transfer to any district and be paid more.

Heidi Kleser teaches at Gause Elementary School and has a 40-mile commute. She spoke about the difficulties in making ends meet and how she is conflicted between her loyalty to the district and thinking about finding a better paying job. She asked the board to consider teachers' wages.

Kelly Gregersen has taught drama at WHS for 12 years. He is passionate about what he does and loves that Washougal has programs worth bragging about, but feels like he is not able to provide for

his family as well as he should be able to on his current salary.

Keri Knight loves her school, her colleagues and especially her students and their families. She has chosen to work here, in spite of a commute, though admits that she is becoming more concerned as she travels through three districts that pay teachers more and show them more respect. It is time to give teachers what is deserved.

Laura Kurtz, first grade teacher at Hathaway, stated that it is time for educators to get the raises they have earned and need. She is discouraged that teachers need to worry about this when they should be focusing on the real work of educating kids. She asked the board to figure out fair and just wages.

Linda Fraught is the mother of two WHS students, and also the wife of a Portland Public Schools teacher. She values, appreciates and admires Washougal teachers. It is high time that they are given a fair contract.

Rhea Bohlin raised two daughters who went through Washougal schools. She recognized that all present appreciate our community and the relationships developed here. She thanked the board members for the immense amount of time they spend volunteering on behalf of the district, and she knows that they do value the staff very much. She is distressed by the division and taking of sides. Her original intention in speaking tonight was to invite board members and audience members to take the Unite! Coalition's annual survey related to youth and substance abuse. This data will be used to direct efforts in the community to lower substance abuse.

Jay Bennett, WHS teacher, stated that he was speaking as a citizen instead of an employee. He expressed concerns that the district's reserves are so large and not being used. Patrons expect that these dollars are to be used for education, and not to be sitting in an account.

Alice Yang read a prepared statement from an anonymous teacher, asking the board to stand up for teachers and appreciate the sacrifices that they are making.

Eric Engebretson, when he spoke at a board meeting a couple of months ago, challenged the board to get this work done so that all involved can get back to the real work. He is concerned that the board listens to comments, but does not respond. He re-issued the challenge.

Jennifer Gay teaches in Vancouver. She stated that she is compensated more and has current curriculum to use. Area teachers are feeling for Washougal teachers.
